Part B (Promotion)

In pursuance of orders contained in Postal Directorate New Delhi Letter No. 25-04/2012-PE-I dated 27-05-2016 and 25-04/2012-PE-I (Vol.II) dated 10-11-2017 and clarifications received from Postal Directorate under the scheme of cadre restructuring of Group C employees of Department of Posts from time to time the competent authority is pleased to order promotion to the officials listed in enclosed **Annexure-A** to the cadre of Lower Selection Grade (LSG) in Post Offices, in Level 5 of Pay Matrix of 7th CPC (Pay scale of 5200-20200 with Grade Pay of 2800/- in the pre-revised scale).

The officials listed in Annexure- A on their promotion to the cadre of LSG in Post offices are allotted to the Region shown against their name. Their promotion will be effective from the date on which promoted official assumes the charge.

Promotion ordered herein is subject to the following conditions:

- Official drawing his/her pay in Level-5 or above in the pay matrix of 7th CPC is not eligible for any fixation under the provisions of FR-22(1) (a) (1). If the official is not drawing the pay in the levels of pay matrix referred to above may exercise his/her option for pay fixation under the provisions of FR-22 (1) (a) (1) within one month from the date of assumption of charge in the promoted post.
- The promotion of the official should be withheld in case the official is under suspension or a charge-sheet has been issued to the official or prosecution for a criminal charge is pending against the official as per DoPT's OM No. 22011/4/91-Estt.(A) dated 14.09.1992. In all such cases, the official should not be relieved for posting without obtaining specific order from this office. The promotion of the official should not be withheld on the mere ground that disciplinary action is contemplated.

The officer against whom any punishment is current except censure and recovery of money, shall not be promoted before expiry of currency of punishment in terms of DoPT's OM No. 22034/5/2004-Esst.(D) dated 15.12.2004 and the fact should be reported to this office at once.

- c) The officials selected against the vacancies reserved for SC/ST/PH category is purely provisional and it is subject to their verification of Caste certificate/Certificate of disability etc. It is the responsibility of the Divisional Head to get the certificates verified at once without delay.
- d) The promotion will remain subject to the outcome of SLP (C) No. 30621/2011 (Jarnail Singh & Ors Vs Lachhmi Narain Gupta & Ors) and SLP (C) No. 31288/2017 and any other court cases in connected matter.
- e) If name of any Accountant line official is appearing in the promoted list, he/she shall not be promoted and name of such official shall be intimated to C.O. for considering such officials for promotion to LSG Accountant.
- f) If name of any official is appearing in the list of promoted officials who has taken VRS, resigned/retired from Govt. service, expired or promoted to other cadre before issue of this order, then he/she should not be promoted and such cases should be intimated to this office.
- g) If name of any official who has declined LSG promotion, one year before the date of issue of this order should not be promoted, such cases should be intimated to this office.
- h) The appointing authority reserves the right either to modify or cancel the promotion, if the official is found not eligible for promotion as LSG or if found necessary for any cause at a later date. For such an order this will be the notice issued in advance. No separate notice will be issued whenever modification / revision / cancellation is ordered.

Instructions given below should be followed while implementing this order:

- a. As per Dte. Letter No. 25-04/2012-PE-I (Vol.II) dated 10.11.2017, LSG cadre remain a circle cadre. However, for better management of transfer and posting and to minimize inconvenience to the staff, Circle would allot LSG officials to Regions for further allotment to Divisions, which in turn shall issue the posting orders. Therefore, the Regional Heads are requested to allot the promoted officials to Divisions within 3 days from the date of issue of this order and Divisional heads will issue posting orders within 3 days to the officials allotted to their division. Allotment of officials by Region and issue of posting order by Division should be completed before **05.05.2023**. Joining or declining of promoted officials should be completed before **31.05.2023**. Timeline should be strictly adhered to. On issue of posting orders, the Divisional Heads will relieve the officials immediately to join in his/her promotional post unless they submit unconditional declination. The Divisional heads of the present divisions will personally ensure immediate relief of the officials.
- b. **The official should accept the promotion within 30 days from the date of issuance of posting order. In case the official declines the promotion, a letter of declining the promotion unconditionally may please be obtained from the official.** If the official neither accepts nor declines promotion within 30 days, it will be treated as deemed to have declined the promotion as per extant rules.
- c. In case the official declines the promotion, his/her case will not be considered for promotion either on regular or adhoc basis for a period of one year from the date of declination or till the next vacancy arises whichever is later.
- d. No representation for re-allotment from the promoted official will be entertained before joining the new post in LSG cadre in the Region allotted. Hence, representations received from the officials

for re-allotment before joining the promotional post need not be sent to this office. Any representation which will received through proper channel will only be entertained by this office.

- e. Divisional Superintendents concerned may please be instructed to relieve the officials immediately so as to enable the officials to join the promotional post within 30 days of this order.
- f. Charge reports may be sent to all concerned. Divisional Heads are requested to forward a consolidated report of assumption/declination of promotion in respect of all the promoted officials pertaining to their division through concern Region on or before 02.06.2023.
